OFFENSE #3: BATTERY- DOMESTIC/ VIOL. F.S.S. 784.03 (1A1)/ COMMITTED

ON Monday, 06/25/12, AT APPROXIMATELY 0743 HOURS, I RESPONDED TO [REDACTED] IN REFERENCE TO A REPORT OF BATTERY. UPON ARRIVAL I MADE CONTACT WITH THE VICTIM BY THE NAME OF [REDACTED] WHO ADVISED ME VERBALLY AND VIA A SWORN WRITTEN STATEMENT OF THE FOLLOWING:

[REDACTED] STATED THAT SHE AND ANSELMO ENRIQUE MORALES-TORRES ARE BOYFRIEND AND GIRLFRIEND AND HAVE BEEN DATING FOR APPROXIMATELY 16 MONTHS, AND ARE CURRENTLY LIVING TOGETHER AS A FAMILY.

[REDACTED] INFORMED ME THAT SHE AND ANSELMO HAD BEEN FIGHTING BOTH PHYSICALLY AND VERBALLY SINCE 2230 HOURS ON 06/24/12. [REDACTED] SAID THAT THE ARGUMENT STARTED OVER HER RECEIVING A TEXT MESSAGE FROM A FRIEND.

ANSELMO SAW THIS TEXT MESSAGE AND ASSUMED SHE WAS CHEATING ON HIM WHICH MADE HIM GO "CRAZY". ANSELMO TOOK [REDACTED]'S PHONE AWAY FROM HER AND LEFT THE HOUSE FOR A SHORT TIME. WHEN ANSELMO RETURNED AND [REDACTED] ASKED FOR HER PHONE BACK, ANSELMO PUSHED [REDACTED] AND TOLD HER THAT SHE WAS GOING TO PAY FOR CHEATING ON HIM AND "I SHOULD KILL YOU", [REDACTED] SAID SHE WAS GONG TO CALL FOR HELP BUT SHE WAS UNABLE TO DUE TO ANSELMO HAVING HER PHONE.

ANSELMO THEN STARTED SLAPPING [REDACTED] IN HER FACE AND KICKING HER IN HER CHEST ALL WHILE HE WAS RECORDING HER WITH HIS CELLULAR PHONE. [REDACTED] STATED THAT SHE TRIED TO LEAVE THE HOUSE BUT ANSELMO WOULD BLOCK THE DOOR AND SLAP HER. [REDACTED] GOT HER SON'S PHONE AND HID IN HIS BEDROOM AT WHICH TIME SHE SENT A TEXT MESSAGE TO A COWORKER SO THAT SHE COULD GET HELP.

[REDACTED] SUSTAINED MINOR BRUISES AND CUTS TO HER ARMS AND LEGS AND WAS TRANSPORTED TO OSCEOLA REGIONAL BY EMS FOR HER INJURIES. [REDACTED]'S SON [REDACTED] (DOB: [REDACTED]03) WAS PRESENT AND WITNESSED THE ENTIRE INCIDENT. [REDACTED] STATED THAT SHE DID NOT GIVE ANSELMO PERMISSION TO TAKE HER PHONE, HIT HER, OR KEEP HER FROM LEAVING THE HOUSE AND DESIRES PROSECUTION.

A BOLO WAS SENT OUT TO NEIGHBORING COUNTIES AND AGENCIES FOR ANSELMO AND HIS RED BMW SEDAN. ANSELMO WAS UNABLE TO BE REACHED FOR QUESTIONING. [REDACTED] WAS PROVIDED VINE AND VICTIM'S RIGHTS INFORMATION AND HELP NOW WAS NOTIFIED. DCF WAS CONTACTED DUE TO [REDACTED]'S SON [REDACTED] BEING PRESENT DURING THE ALTERCATION. PHOTOS OF [REDACTED]'S INJURIES WERE TAKEN AND SUBMITTED INTO EVIDENCE.

IN THE PROCESS OF MY INVESTIGATION I HAVE PROBABLE CAUSE TO BELIEVE THAT THE CRIME OF BATTERY [VIOL. F.S.S. 784.03 (1A1)] WAS COMMITTED BY ANSELMO WHEN HE SLAPPED, HIT, AND KICKED [REDACTED]. I HAVE PROBABLE CAUSE TO BELIEVE THAT THE CRIME OF TAMPERING WITH VICTIM [VIOL. F.S.S. 914.22 (1)] WAS COMMITTED BY ANSELMO WHEN HE DEPRIVED [REDACTED] OF A MEANS TO CONTACT LAW ENFORCEMENT FOR HELP BY TAKING HER CELL PHONE IN ORDER TO CALL 911.

I HAVE PROBABLE CAUSE TO BELIEVE THAT THE CRIME OF FALSE IMPRISONMENT [VIOL. F.S.S. 787.02 (1A)] WAS COMMITTED BY ANSELMO WHEN HE USED FORCE TO NOT ALLOW [REDACTED] TO LEAVE THE RESIDENCE SO THAT SHE COULD GET HELP. CHARGES WERE FORWARDED

MS. [REDACTED] STATED THAT AT APPROXIMATELY 0905 HOURS, SHE RECEIVED A TEXT MESSAGE FROM [REDACTED] STATING THE FOLLOWING:  
CHICHI IS TRYING TO KILL ME. HE IS GONNA CALL THE JOB AND LIE SO I COULD GET FIRED IM HIDING IN THE HOUSE  
HE SAIDS I CHEATED ON HIM. WHEN HE HAS DONE IT TO ME HE HAS BEEN HEATING ME SAYING IM GONNA PAY, THEN HE RECORDED ME AFTER HE HIT ME AND SAID HE WAS GOIN TO USE THAT SO I COULD GO TO JAIL. SAYING I WAS HITTING HIM

SHE THEN STATED THAT SHE CALLED THE SHERIFFS OFFICE TO REPORT THE INCIDENT.

AT THE SCENE I OBSERVED THE MENTIONED TEXT MESSAGES ON MS. [REDACTED] CELL PHONE. IT SHOULD BE NOTED THAT THE TEXT MESSAGES CAME FROM PHONE NUMBER [REDACTED]. D/S R. TATOLLI THEN TOOK OVER THE INVESTIGATION. PLEASE SEE HIS REPORT FOR FURTHER.
