Rego also falsely claimed to be qualified to handle the job given his past experience working at Kimball Beach Road on a seawall- falsely claiming to have previously dealt with the Hingham Conservation Commission and from that having an understanding of the process and requirements needed in order to gain approval from the town for construction of a new seawall.

The Hingham residents would have not hired Rego if they understood he was not an agent/employee of John Chuckran.




