This made me very uncomfortable and again scared that he and his followers would show up at my house where I reside with my elderly parents and husband. He showed up at our house uninvited at 9:15pm on 3/1/23 and attempted to turn the turn the door handle after opening the screen door—the door was locked and made sure it was closed— it kept knocking and recording on his phone. I called Newton Police and let them know I feared for my and my parents safety. By the time the police arrived he had left— however he was recording from down the street and posted it on his website.
