On Friday, February 16th, 2024 at approximately 1832hrs Sgt. Eaton and I, Ofc. Crosman was dispatched to Creek Street at South Street on the report of a motor vehicle vs. pedestrian crash. Sgt. Eaton and Sgt. Morris arrived at the scene before my arrival and assisted the pedestrian, identified as MICHAEL Barry, until Wrentham Fire arrived to evaluate him. MICHAEL sustained a laceration to the right side of his head and was complaining of left knee pain, and was transported to Sturdy Hospital by Norfolk Fire.

MICHAEL was walking with a cane on South Street wearing a reflective yellow vest and had just entered the roadway/crosswalk South Street at Creek Street when he was struck by MV#1, Massachusetts registration#5JCD59. The operator of MV#1, HELENA Rafferty, stated that she was turning left onto Creek Street from South Street and did not see the pedestrian before the crash. HELENA stated that she immediately put her vehicle in park and exited the vehicle to assist him and did not move the vehicle before our arrival.

I observed MV#1 at the scene and took photographs of the damage and location (see attached photographs). There was a white scuff mark on the passenger front bumper from either MICHAEL's person or his cane (see photograph). No other damage was noted to MV#1, and it did not require a tow as it was operable. I observed the area of the crash to be poorly lit with only one fluorescent light. While taking photographs, ROMA Pristza came over to me and informed me that she had witnessed the crash. At the scene, ROMA stated that the female operator of MV#1 was not operating erratically before the crash. ROMA provided an email witness statement (see attachment).

HELENA requested that she be breathalyzed at the scene. Using a Drager PBT, I initiated test number 00009 and administered the test, having HELENA blow into it. The result was 0.00, which I wrote into the Drager log. HELENA was issued a civil citation (#452999AC) for Failing to Yield to a Pedestrian in a Crosswalk. No further information is available at this time.
