Officer Joseph Foley July 20, 2024 1919 Hours Disturbance / Disorderly

On the above date & time, Officers Mcgraw, E. Foley, Sgt Espinoza, and I responded to the Shipwrecked Restaurant for a reported fight in progress in the courtyard area. Dispatch would later report that things were settling down and there were no reports of injury.

I would arrive on scene first, and I observed a few staff members in the parking lot. I briefly spoke with one , who was not sure what was happening. I then went to check the courtyard area of the managers and saw no active disturbance before continuing inside and ensuring that the disturbance had not moved inside.

Once I was sure that there was no ongoing disturbance, I would return the parking lot to speak with staff. I 3 , who told me that there had been an argument between two groups of spoke with one of the managers, told me that one group, two males, had left prior to my arrival. The other group, guests at the restaurant. identified as Jillian Daniels and Nicholas Marathas, were sitting on the steps to The Heights Hotel next door. told me that the two groups had been arguing in the courtyard, and she had been attempting to separate them when they left and moved to the bathroom area and continued arguing. stated that again she got in between the groups to try to separate them, and told Jillian and Nicholas to leave. As escorted them out of

the building, she felt two hands behind her shove her into the inner door of the entrance.

would later email me her statement (see attached) and is as follows: On Saturday July 20th, 2024 I was alerted to a confrontation outside in the Courtyard. I saw two men arguing intensely and a woman who was obviously very upset. She was shouting and being very animated by pumping her fist and pacing.

My main concern was to separate the men immediately. I did not know what the argument was about but it looked like it was about to get physical. I stepped up and let the man and woman know it was time to go. I learned their names were Nick and Jillian. I started to lead them to the Courtyard exit but they went inside the restaurant instead. I followed them in and Nick got into another confrontation with the same man who was standing outside the mens room. It was all I could do to keep them from coming to blows. I got between them and I instructed the other man to walk away which he finally did.

We made it to the front door through a gathering of customers waiting to be seated. I went ahead of Jillian and was following behind Nick. Jillian was yelling at me the whole time. She could not seem to get control of herself. I assumed she was angry with me for kicking her out.

When we reached the door, she was behind me. I heard her say something like 'I bet you're for Karen Read' to me. She then shoved me with both hands on my back from behind.

I believe Nick restrained her and we made it outside. She stood on the ramp screaming at me. Saying things like 'old hag' and 'c*nt. Some coworkers were there to support and she screamed similar things to them. I repeatedly asked Nick for them to leave. He was standing at the rail on the ramp. He told me 'You don't know the whole story'. I never spoke to Jillian as she was screaming at me the whole time.

I didn't know what the fight was about until later. I didn't care what it was about or who said what to whom. I was focused on removing the threat from the property and the safety of other customers, including children.

The police arrived and took charge of the situation. I looked for the other party as I wanted them to leave as well. They were already gone.

- would eventually get Jillian and Nicholas outside, where another manager, was able to deescalate the situation, and separate them until officers arrived. When I spoke with she told me she did not want to press charges, but that Jillian and Nicholas were not welcome back today. stated they would make a later decision on filing a written notice of no trespass. I would verbally notify Nicholas and Jillian of a order of no trespass for the day, and they would leave the area on foot.
- On July 25, I would speak with one of the servers,

 Waited on a table that was involved, and that they paid with a credit card. I would go to Shipwrecked and retreive copies of the bill for that table, as well as three bills for Nicholas Marathas (see attached images). Note: I was advised that Nicholas is known at the bar and is known to pay for other people's drinks. The other party's bill was paid for by "Georgea Berube." I would speak with George A Berube at his home. Initially George denied being at the restaurant until I showed him a copy of the bill. He then told me he was there with his friend Leo Goodrich and

 George then denied knowing anything about any disturbance, and only when I told him that his bill was paid for 15 minutes before police arrived did he tell me that he heard what he called "discussions" but paid for his bill and left.
- 8 I would also attempt to review camera footage, but Shipwrecked has no coverage inside the restaurant or covering the courtyard.
- When I returned to the station that same day, I would call Leo Goodrich, who had called me and left a message. He told me that he was there and a younger male that he knew only by the first name "Matt" had called out that Jillian Daniels was at the restaurant. From there Nicholas Marathas started yelling at "Matt" and another man "Matt" was with. According to Leo, "Matt" then went inside and Nicholas followed him. Leo told me he and Jillian followed as well, and during the disturbance Leo admitted to me that he called Jillian "white trash." At that time, Nicholas pushed several people to try to get at Leo, but was restrained. At that time Leo left with his mother and George.
- I would also speak with who was working the inside bar when she observed Nicholas, Jillian and "a trail of staff" leading out to the front door. described seeing Jillian push as like a "hip check" while motioning to me a strike with her elbow, and stated Jillian struck from behind. also told me that she did not know Nicholas well, only that he was a regular at the restaurant.
- On July 25 I would return to Shipwrecked and spoke with

did not see anything. I spoke with who posted on social media about the incident, but she told me that she did not see anything. Detective Carpenter would speak with Nicholas Marathas (refer to Detective Carpenter's narrative)

I would call Matthew, who picked up stating "Hello Falmouth Police". I told Matthew that I was calling about Saturday night, and that I was looking for his side of the story. Matthew told me he didn't know what I was talking about, and that he didn't know where he was that night. I told him that I had a witness that placed him in the courtyard at Shipwrecked, calling out Jillian Daniels. Matthew asked me who Jillian Daniels was, and would not confirm or deny if he was at the restaurant. I assured him that I only wanted to get his side of the story, and he told me "I might have said something fresh", but Matthew continued to be evasive during the entire conversation, and asked who Jillian was several times. I gave Matthew my phone extension number, and told him he could call me back when he felt like cooperating.

On July 27 I would return to Shipwrecked to speak with

He told me that he was at the host station when he looked over and saw "off balance" and the two groups "rapidly approaching" each other. then followed inside where he saw Nicholas attempt to "bullrush" Leo.

Nicholas, but he stated that he thought Nicholas was punching Leo, who was behind also stated he saw Jillian push from behind and using both hands.

Marathas informs this officer that earlier in the day on the day of this incident, he and his girlfriend Jillian were visiting Marthas Vineyard. When leaving Marthas Vineyard, they decided to go Daniels! (Shipwrecked is a local bar/restaurant located at 269 to Shipwrecked to visit their friend/bartender is employed by Shipwrecked.) Grand Ave. in the Town of Falmouth.

Marathas states that while outside with Jillian in the courtyard portion of the establishment, an unknown male immediately screams out in a provactive manner "Jill Daniels is in the house!"

The unknown male and members of his party also called Daniels "White Trash."

NOTE

Marathas repeatedly tells this officer that he and girlfriend Jill Daniels have been constantly harassed, provoked, or screamed at, because of the Karen Read Trial.

As the unknown male is screaming out towards Daniels, Marathas confronts him yelling back "What's your fucking problem!"

A verbal argument ensues between Marathas, Daniels, the unknown male and members of his party.

The manager approaches and attempts to separate all parties. The manager tells Marathas and Daniels that they have to leave.

As they walk inside the restaurant, a second altercation erupts between Marathas and the same unknown male in the area of the Men's Room.

Marathas admits that he attempted to get at the unknown male and hit him, but missed.

As the conversation continues, Marathas states "The manager didn't even hesitate and tosses Jillian, which she should have. But, Jillian didn't lose her temper at first, I did!"

He goes on to say that whenever they are out, they are constantly screamed at, harassed or provoked, which instigated this incident. Although Daniels was animated and upset, he did not witness Daniels assault anyone during this incident.

I instruct Marathas to have Daniels contact me in an effort to get her version of events. Upon completion of this report, she has not contacted me. RMC.

- On 7/20/2024 at approximately 1919 hours I was dispatched to 263 Grand Ave (Shipwrecked Restaurant) for a fight in progress.
- 2. Upon my arrival there were several units arriving at the same time. I exited my cruiser and a bystander pointed to where there was a male and a female sitting on the stairs of The Heights Hotel. I walked over to them and the female identified herself as Jillian Daniels and the male identified himself as Nicholas Marathas.
- 3. I started speaking to Daniels who was visibly upset with tears in her eyes. I asked her what had happened and she stated to me that there was a group of people who were targeting her calling her names and taking pictures of her. I asked her if she knew them and she stated no. I then asked why they would be targeting her and she stated to me that it was "all about Turtle Boy" and "the fact that I am from Canton". Daniels then stated to me that they were targeting her because of the "Karen Read Trial". Daniels repeated herself several times and continually broke down in tears.
- 4. While Daniels was continually repeating herself Marathas was sitting next to her and telling her to stop. Marathas stated to her several times that she did nothing and to calm down.
- 5. I then left Daniels and Marathas and went to speak to Officer Foley who then went over and spoke to Daniels and Marathas.
