**NARRATIVE**

On Monday March 11, 2024, Lindsay Gaetani met with me at the Dedham Police station to discuss items in a folder she had handed over to Officer O'Sullivan on March 9, 2024.

Speaking with Gaetani we went over items in the folder, which I counted along with Gaetani as 65 pages. I asked Gaetani if this is what she presented to Officer O'Sullivan and she informed me it was.

After going through these photos, the items pertaining to the restraining order violation (Docket #: 2354RO0429) consisted of:

Pages 1-4 and confirmed with Gaetani was a typed statement by Gaetani and signed by Gaetani of the events that had transpired on February 26, 2024, as well as her past history with Kearney.

Pages's 5 and 6 consisted of a screen shot of a video of Gaetani exiting superior court on February 26, 2024, Gaetani could not state whether these videos (screen shots) were taken by Kearney.

Pages 7-17 are photos Gaetani received from her friend "Meagan Mccabe" which she stated shows KEARNEY at the Dedham Registry of Deeds when she (Gaetani) is exiting Dedham superior court. The photos are also location stamped and time stamped. I asked Gaetani is she could recall these moments. Gaetani informed me she arrived at Dedham Superior Court around 1:30pm and as she was about to enter the court room around 2:00pm is when she observed KEARNEY inside the court room, Gaetani then informed a Court Officer that she has an active restraining order (Docket #: 2354RO0429) against KEARNEY. Gaetani stated that KEARNEY exited the Court room around 2:05pm. Gaetani informed me that she exited Dedham Superior Court around 2:30pm and as she exited "there was a lot of yelling going on at the time, people were screaming murderer, and I could see Kearney across the street (Dedham Registry of Deeds) pointing his cell phone in my direction and at one point was (KEARNEY) hiding behind a tree". Gaetani stated she felt anxious and nervous while attempting to walk back to her vehicle during this sequence of events.

Page 22 was a screen shot of a call log Gaetani made on February 26, 2024, to the Dedham Police Department at 3:07pm which lasted 8min and 58 seconds. Gaetani informed me this is when she attempted to report the violation of the restraining order but was told she had to make this report "in person" and not via the telephone. Gaetani informed me that she could not come to the Dedham Police Station at that moment as she was driving to pick up her child from school.

Pages 31-65, Gaetani informed me was an article posted on Kearney's website pertaining to the events on February 26, 2024. Gaetani pointed out photos of her entering the Dedham Superior Court on that morning (02/26/2024), inside Dedham Superior Court and exiting Dedham Superior court. Gaetani informed me that none of these photos she believes were taken by Kearney to her knowledge. Gaetani informed me that after seeing this article she started to get a panic attack and has been having panic attacks from on-going personal attacks from Kearney.

Gaetani also notes that she is the victim in a witness Intimidation case (Docket#:2482CR00043A) involving Kearney and that a fake X account @BettyB17033 (created February 2024) with a profile picture of her face (Gaetani) taken by KEARNEY when the two were engaged in sexual intercourse. Gaetani believes KEARNEY is the only person that has possession of such photo leading her to believe that KEARNEY is the account holder of @BettyB17033.

Based on the fact that Gaetani is a named victim in the witness intimidation case (Docket#:2482CR00043A) and Kearney violating the restraining order (Docket #:2354RO0429), the

article discussed previously in this report and the apparent use of an X account @BettyB17033, KEARNEY appears to be engaged in a pattern of conduct intending to harass and intimidate Gaetani.

The folder which Gaetani provided was turned into evidence and attached to the incident.

A copy of this report was emailed to special prosecutor Mello.

To Whom it May Concern:

On February 26, 2024 I attended the hearing of Karen Read at the Dedham Superior Court at 2pm. I attended the hearing with the family of John O'Keefe and some of the other witnesses in the case. We all met and parked in the large parking lot behind the Registry of Deeds prior to the hearing and walked into the courthouse together in two large, separate groups. After we parked, a member of our group called the victim advocate representing the O'Keefe family to let him know that I was with the family and that I have a restraining order against someone that we believed could be inside or outside of the courthouse. We were instructed to have my restraining order on hand and to show it to the court officers when we entered the building.

As we walked into the courthouse there was a large crowd that were yelling obscenities at us when we passed them. After entering the courthouse we were brought into a room to wait until the hearing began because the halls were filled with protestors. When it was time to enter the courtroom, I informed the court officer of my restraining order. We then entered and I had a seat in the courtroom on the benches to the right. Shortly after being seated, the person I have a restraining order against- Aidan Kearney- was told he must leave the courtroom by a court officer, which he proceeded to do.

When the hearing was over, I left the courthouse with the same group I entered with. As we walked outside we encountered the large group of protestors who were again all screaming obscenities at us as we passed. We walked down the ramp of the courthouse and proceeded down the sidewalk to the right, and then crossed the crosswalk to go across the street towards the parking lot where we parked our cars. Before we crossed I noticed Mr. Kearney standing by himself next to some trees/bushes holding his phone up in my direction as if he were taking pictures and or video. As we crossed the street I saw him moving towards the wall on the side of the Registry of Deeds building in an attempt to follow us and continue filming, still holding up his phone. Because my car was parked in the lot behind the building, I had no choice but to walk in his direction, essentially trapped and unable to avoid him. After we crossed the street he was now to my left, standing on the wall, and I believed that I heard his voice yell "LIAR". However, there were a large number of people so it is hard to say for sure whether it was him that yelled this. We continued walking to the parking lot and I did not engage with him or any of the protestors.

When we got to our cars parked in the very back of the parking lot, the first thing I noticed was that my back driver-side tail light was smashed, and upon further examination I saw that there was also a large mark and dent going from the taillight all along the back quarter panel extending to the sliding door (as if someone had used some kind of object to smash the taillight and drag it along the side of my car). Our group discussed if we should call the police- as we were nervous from being told that the group of protestors may be coming to follow us to the parking lot- or if I should drive to the police station to report it. But someone from our group called the police, who quickly arrived. The officer, Officer Kozack, took a report and at this time we could see a group of protestors at the opposite far end of the parking lot walking in our



direction. Due to this, and the fact that I had to be back in Medfield at 3:10pm to get my son off the bus, I decided to call and follow up with the police about the encounter with Mr. Kearney on my drive back to Medfield. I got in my car and soon after called the police back at 3:07pm to report the potential restraining order violation. The police told me that I would have to drive back to the Dedham Police station to report it in person. I explained to them that I would have to wait for a sitter to come stay with my kids and then would return, which I did. I went back to the police station once a sitter arrived to watch my children, around 7pm that evening, and reported my encounter with Mr. Kearney.

The next day Mr. Kearney posted a blog about me titled, "Canton Coverup Part 299: McAlberts Use Fake Domestic Violence Victim Lindsey Gateani As Human Shield To Evict Award Winning Journalist From Karen Read Hearing". In this blog he posted 19 pictures of me, 16 of which were pictures of me from the court hearing (both inside and outside of the courthouse). He also posted a completely irrelevant, unflattering, and enlarged picture of me from the summer of 2023 long before I even knew Mr. Kearney, which was taken during a trip to a waterpark with my children. In his blog he disparaged my name numerous times (like he has done hundreds of other times in recent blogs).

For example, he made up this lie about me and wrote:

"It should be noted that she would've had to get a babysitter for her kids and she hasn't had a job since 2017 since getting fired at Stop & Shop for nodding off during a bender. But I guess for some people trolling Turtleboy and supporting murderers is more important than taking care of their kids."

He also said,

"Lindsey had never previously attended a Karen Read court date, including the January 5 and January 18 hearings when I was in jail. But she showed up at the last minute today, holding the restraining order papers in her hands as a weapon, and has clearly gained a few pounds. Yikes."

And also,

"After court I confronted Paul O'Keefe and asked him why he continues to disgrace his brother's legacy by showing up arm in arm with the people who murdered his brother. His mother Peggy O'Keefe then gave me the finger and said "where's Lindsey," because using this mentally unstable degenerate DCF Mom as a human shield to prevent me from attending court dates is standard behavior from them."

These are just a few of the harassing comments he has made about me in this particular blog, and just an example of ONE of the many blogs he has written since being arrested in which he slanders me and uses my full name and pictures.

In fact, just in the 60 days he was in jail, he mentioned my name 92 times in his blogs. This is not including the other numerous times he has spoken about me on social media and his live YouTube shows. I was told by the police that these are not restraining order violations because he doesn't directly speak TO me, rather just ABOUT me.

In his numerous YouTube shows since being released from jail he has continued to defame me. He has lied and told his viewers that I am addicted to drugs and that I shouldn't be allowed to hold my registered nursing license or have custody of my children. This has resulted in numerous calls to DCF and my children's schools from his followers who have reported false claims of abuse and neglect in an attempt to get my children removed from my custody, as well as numerous calls to the Board of Nursing to try and get my nursing license revoked.

In addition, Mr. Kearney has created several new Twitter accounts where he has been harassing me and taunting me. One account in particular was created under the name "Betty Boop" (bettyb17033). The profile picture is a screenshot of my face from a video that Mr. Kearney took of the two of us having sex. Mr. Kearney is the ONLY person who would have this video. The profile contains dozens of slanderous posts about me including:

- My high school yearbook photo from 2004 with a caption that reads: Most likely to get fired from Stop & Shop for nodding off while bagging groceries.
- A picture of me from my nursing school graduation where I was the class speaker, captioned with: "God bless the meth mile road that led me straight to use".
- A video from my nursing school graduation with a caption that says, "It's a sin Mass Bay didn't have a crystal ball to see Lispy Lindsey would relapse soon after this charity. What a waste! Rest assured, your loved ones will not be in her care. Hopefully her children aren't for much longer either."

Amongst several other posts criticizing my appearance and my parenting.

There was also another Twitter profile created that shows the profile name as 'Aidan Kearney' and the username as 'LGaetaniPornHub'. On a recent episode of one of Mr. Kearney's live shows called Turtleclub, Mr. Kearney says that he wants to show his viewers some recent Twitter posts. In doing so, he shares his computer screen and you can see on the bottom left of the screen that he is logged into this account and didn't realize it, proving he is the person that created and is maintaining this account.

He also created other similar accounts in the past, including one where he uses a picture of my 2 year old daughter and I for the profile picture, with the username LGaetaniOF, titled "Gaetani on Pornhub" and captions it, "Ghetto ho addicted to heroin who needs your attention, follow me on Pornhub!"

This incessant harassment and torture of me and my children has not stopped since Mr. Kearney was first charged with assaulting and intimidating me. He even said in one of his blogs that I should expect charges myself soon and that there is "still time" for me to "tell the truth".

Mr. Kearney has also been contacting estranged family members of mine and abusive ex-boyfriend's to try and illicit private and disparaging information from my past, which he continues to share on his platforms.

I perceive this harassment as continued intimidation against me so that I will not testify against him in his upcoming cases. I continue to be in great fear of this man and have become scared to even leave my house, especially after what occurred at the Karen Read Hearing in which my car was vandalized and Mr. Kearney showed no regard for the restraining order as he loitered outside the courthouse waiting for me to exit and followed me on my walk to my car.

I have not contacted Mr. Kearney at all since obtaining my restraining order, except for an accidental call which took place on February 22, 2023 at 1:57am while I was attempting to screenshot text messages between us to add to my binder of evidence the night before my grand jury testimony. Mr. Kearney was still in jail when this accidental call took place, and I had absolutely NO intention of trying to call him or speak to him. This was an accident and I texted my friend, Kate Peter, about this as you can see in the attached screenshots of our texts. I have not responded to any of Mr. Kearney's harassment in any way. I have not spoken to him or about him in any way. Yet he has continued to harass me and smear my name. He also doxxed me on a recent episode of his live show by showing his viewers a copy of an interview that I had with a Massachusetts state police detective. This police report showed my full name, address and phone number to his thousands of viewers.

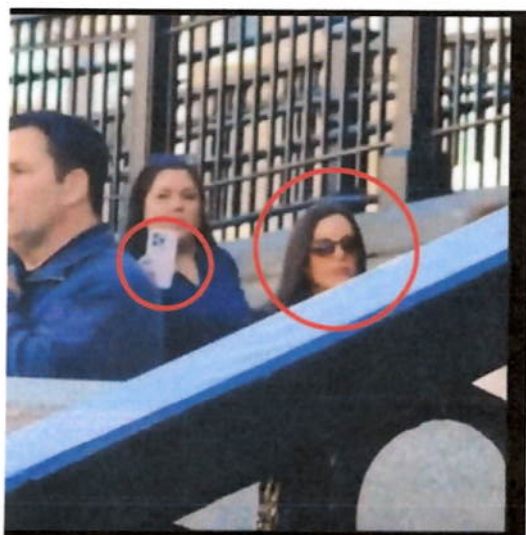
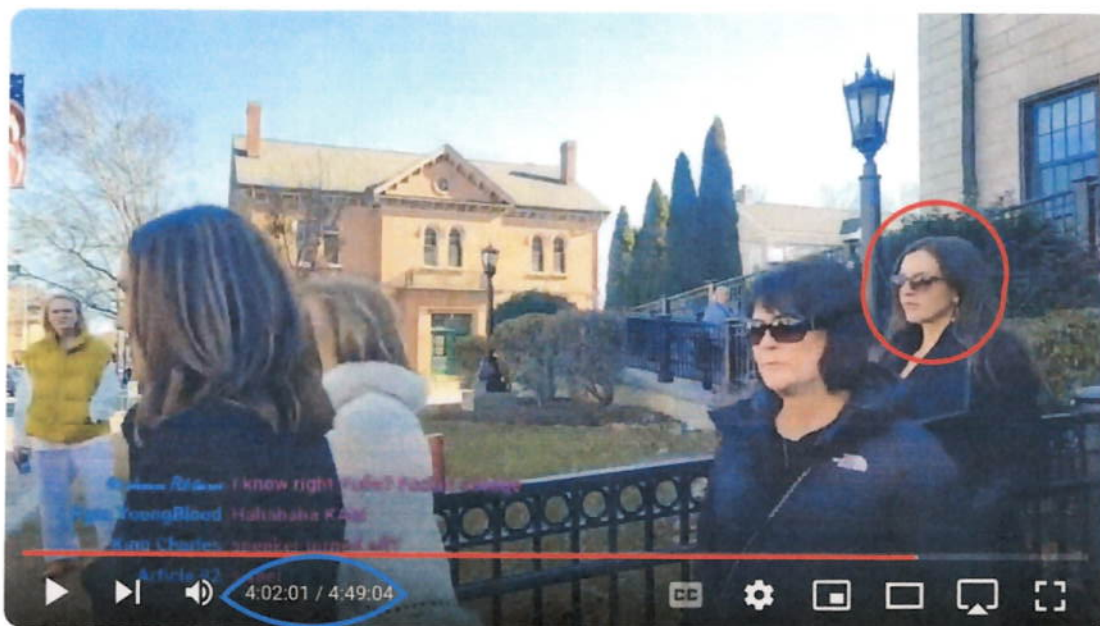
When Mr. Kearney was removed from the courthouse on February 26, 2023, he continued to wait for me outside, well within the 100 yard exclusion zone of my restraining order, instead of completely removing himself from the area as he should have. He taunted me from across the street and continued to film me and take my picture, which he later used to create yet another blog about me where he lied about me and slandered my name. Mr. Kearney has shown a blatant disregard for the court, the law, and my restraining order, and is continuing to put me and my children in extreme fear for our lives.

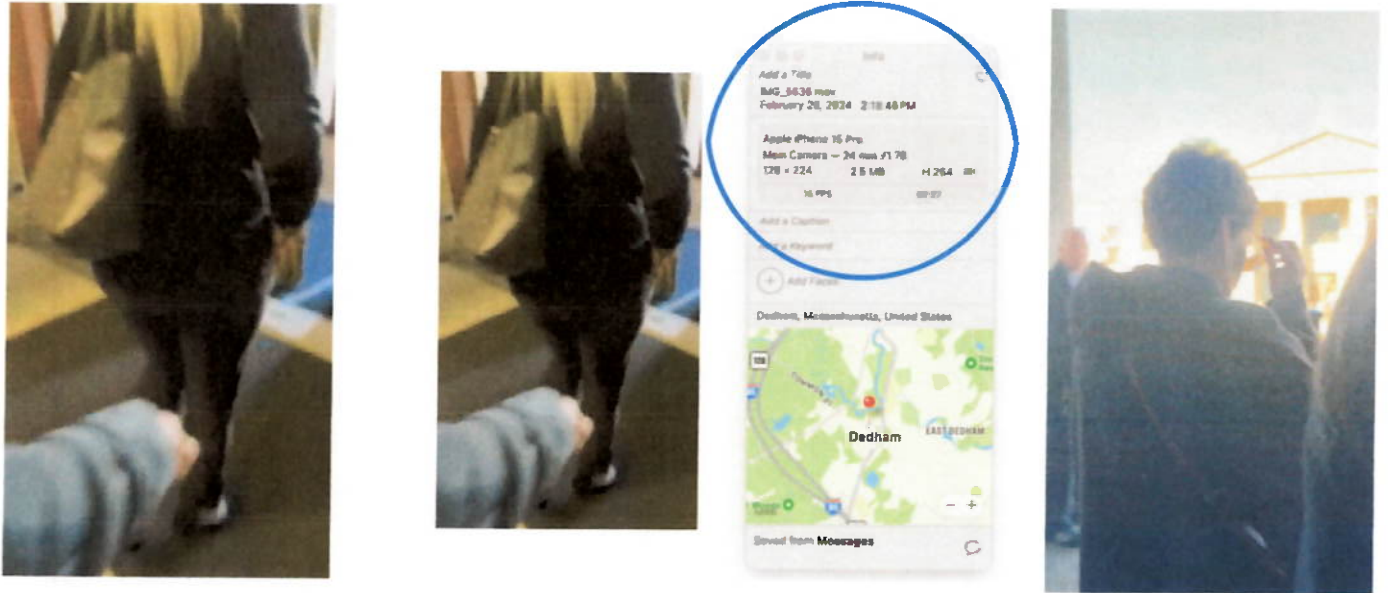

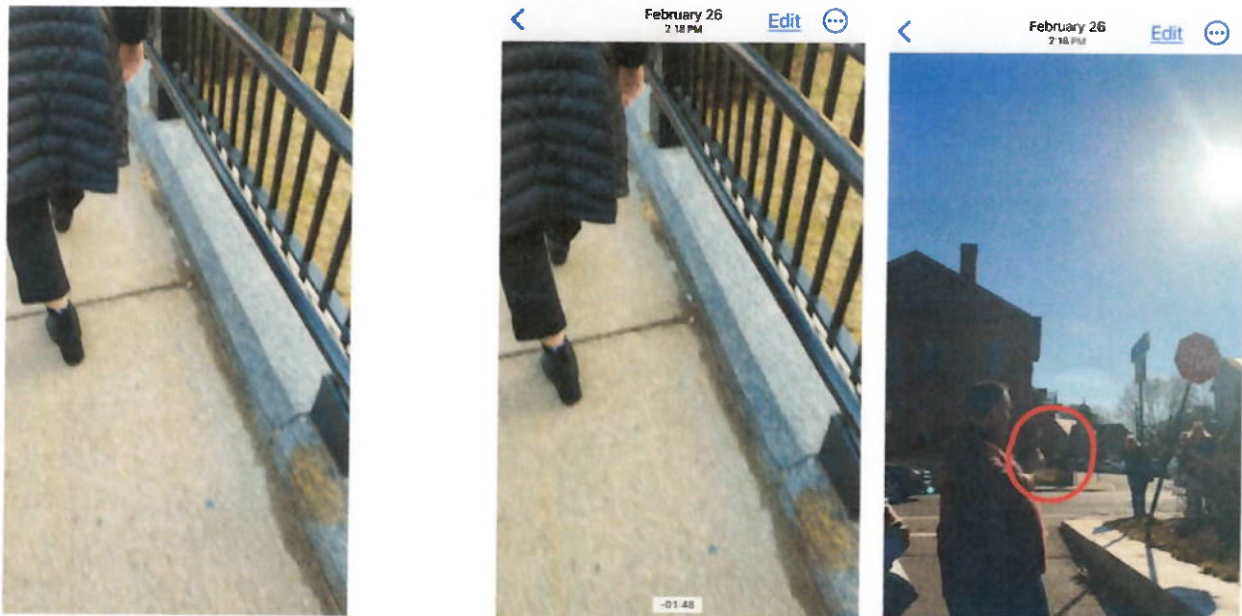

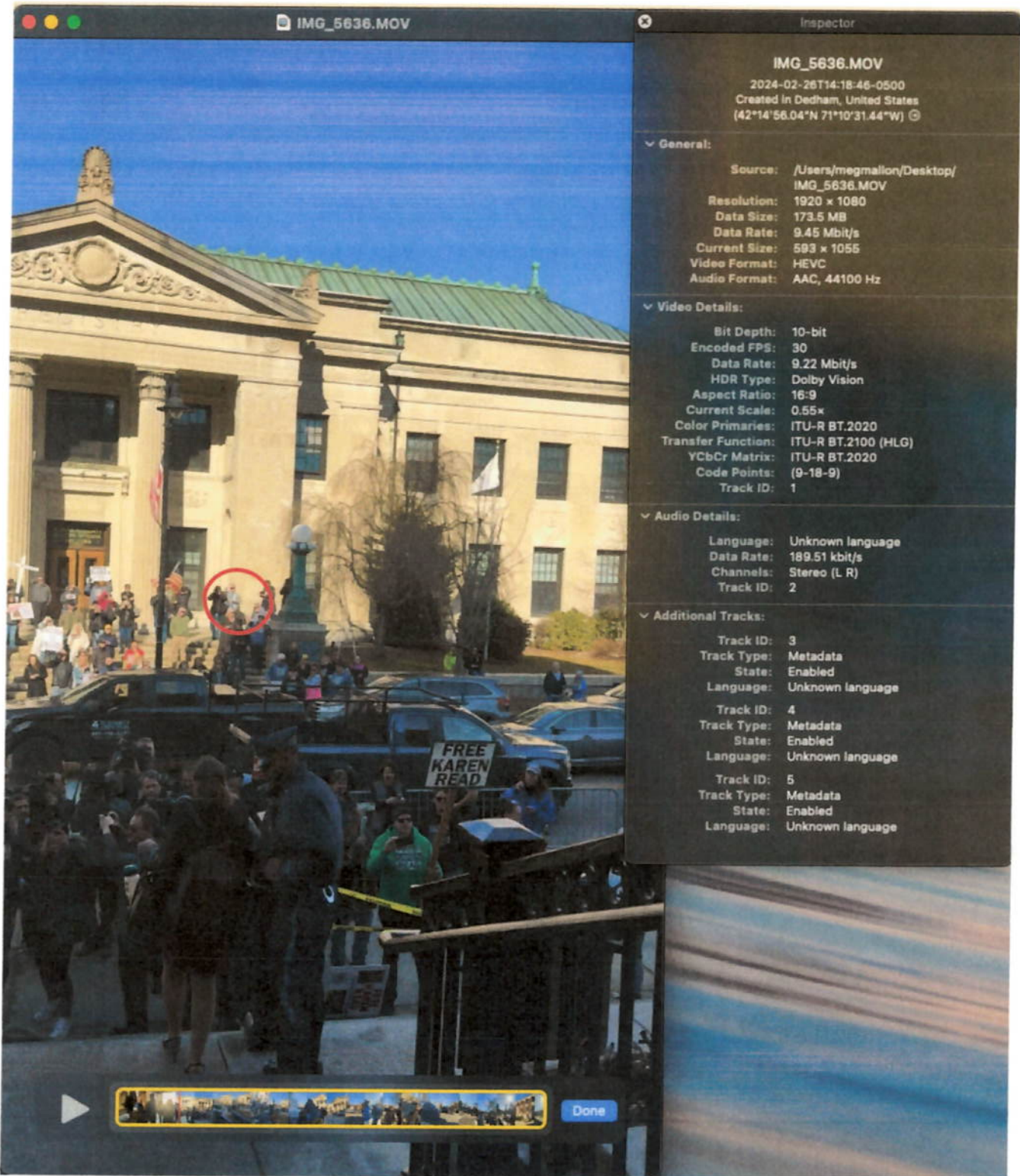
Filmer # 1 - Video and screenshot with Metadata - February 26th 2:18 pm

The real loser here are women who are victims of domestic violence. It's so hard for real victims to be believed because of women like Lindsey Gaetani. Most women will go their whole lives without ever having a man arrested for assaulting them. Lindsey has had 4 – Me, Frank Keegan, Nick Bonifilio, and her father Michael Gaetani. It's almost as if there's a common denominator here.

Luckily I didn't miss much of a hearing. The big news was that over 3,000 pages of discovery were handed over from the Feds, so the trial date is being moved to April. The Commonwealth claims that 90-95% is "consistent with the Commonwealth's theory of the case," meaning at least 5-10% of the evidence is exculpatory. The defense claims that all of it is exculpatory. Of the two, only the Commonwealth has a documented history of lying in court. We will attempt

to get the order against me amended so that I can attend court dates moving forward, since I am listed as a witness in the Karen Read case, have been covering it extensively for months, and the only purpose of Lindsey showing up is to make me leave. Judge Krupp amended the order against the McAlberts to do the same in November.
