Now comes the undersigned, [REDACTED] on oath, and hereby states the following to the best of her knowledge, recollection, information, and belief, under penalties of perjury this 21<sup>st</sup> day of April, 2025:

1. My name is [REDACTED] I reside in Massachusetts.
2. I am of age and competent to make this affidavit.
3. I have been friendly with Katherine Peter, hereinafter Peter, for close to a year.
4. I have had multiple conversations and face-to-face interactions with Peter.
5. Peter volunteered information to me about the Karen Read case countless times throughout our friendship. All factual representations below are from what Peter told me about her involvement in the Karen Read and Aidan Kearney cases.
6. During Karen Read's first trial she was in regular communication with ADA Adam Lally. At one point prior to jury deliberations, Peter met with Adam Lally for lunch. During this lunch meeting, Adam Lally told Peter that he knows the foreperson who

is a retired police officer and he [the juror] is guaranteeing a mistrial. This is what was verbally reported to me by Peter.

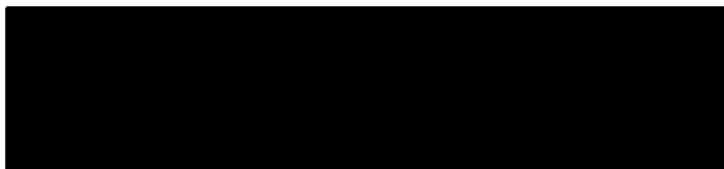
7. She told me she is paid \$1500 each month, via CashApp, for her assistance in the Karen Read and Aidan Kearney prosecutions.
8. Peter believes that Karen Read is innocent, but she has to “play the game”. I interpreted this to mean Peter’s role is to publicly promote and advocate on social media that Ms. Read is guilty. Peter opined to me that “if anyone killed John, it was [REDACTED] an asshole.”
9. Peter is “very close with Hank [Brennan]” and has had multiple conversations and meetings with him. I have personally heard Peter on the phone with Hank Brennan.
10. During a phone conversation between Peter and Hank Brennan, that I was present for and personally recognized Hank Brennan’s voice, Peter told him that her “people leaked it [to the media]” referring to the federal investigation being over.
11. As of April 15, 2025 Peter is “not talking directly to Hank anymore. We’re using a third party to communicate now.”
12. Peter states that she is “untouchable” because of everything she is doing to assist the prosecution and that “no matter what violations I’m charged with, Morrissey is keeping me out of jail.”
13. Peter asked me to “go stalk Karen Read in the Seaport” with her and stated that Karen Read stays at the OMNI Hotel. She stated to me that we can take photos to sell to the Daily Mail and that she has done that before.
14. Peter informed me that Jennifer McCabe bought her “brand new sectional” as compensation for her assistance.

15. Peter was told by Jennifer McCabe that Jennifer McCabe informed Michael Morrissey that she is “not testifying unless Turtleboy is in jail.” Michael Morrissey informed Jennifer McCabe he would then have to subpoena her and Jennifer McCabe then told Michael Morrissey “then we won’t say what you want us to say”.
16. Peter got rid of her phone the day after Aidan Kearney announced on his live show that he was looking to get personal communications of Michael Morrissey. Peter said to me “they will never get the communications between me and Morrissey.”
17. The day that Peter showed up to protest at the Karen Read trial, Peter informed me “Jen McCabe paid me” for her show of support.
18. On March 16, 2025, Peter told me that she went to meet with Michael Morrissey and Jen McCabe at an undisclosed location in Braintree. When Peter returned home, she had a manilla envelope in her hands.
19. Peter has informed me that she has seen emails that are subject to a protective order, between the Karen Read prosecution team and Jennifer McCabe.
20. Peter reported to me that upon request of Hank Brennan, she provided the spreadsheet of all of the “Free Karen Read” Facebook supporters to the Commonwealth for this upcoming trial.
21. Peter told me that Hank Brennan is providing information to the Federal Authorities regarding Karen Read and Aidan Kearney because “he wants them in jail for the trial.”
22. Peter told me she is going to “start rumors about jurors being afraid to serve because Turtleboy will go after them.” and “Everyone is working overtime to make sure that Turtleboy can’t be in the court room for the trial.”


23. Peter admitted to me that she created the image of Karen Read and Alan Jackson embracing, that was then given to the Daily Mail.
24. In early January, Peter and I were discussing the Lindsey Gaetani case against Aidan Kearney. I mentioned something about Gaetani being pregnant at the time, and Peter interrupted me saying "Lindsey was never pregnant." I am aware that Peter and Gaetani were close friends in the past and worked together against Mr. Kearney.
25. I understand that I am not represented by any attorneys connected to the Aidan Kearney or Karen Read defense teams and that I am turning over this information because it is important to know the truth about what is going on.
26. I am not being coerced or compensated and I am doing this of my own free will.
