Sir,

On May 25, 2024, I, Ofc Fernandes, was assigned to a uniform patrol unit #23. My assignment is to patrol the Southend of New Bedford in the sector of Unit #23. At approximately 9:25 PM, I was dispatched to a disturbance at 160 Annette St for people fighting.

Upon arrival, I observed a female (Nicole Bishop, DOB 12/06/92) holding a baseball bat standing outside a black Toyota bearing Ma plate 3AKN17, attempting to help her friends who had been pepper sprayed (Savannah Araujo DOB 05/04/97 and Tiffany Arndt-Ellis DOB 7/29/90). Nicole stated it was Genele Underwood, DOB 6/12/90. Nicole was able to provide me Genele's information because Savannah had a copy of OF-24-3224 in her car. I was able to get Genele's DOB and address from the report.

Savannah stated that she was in the car with Tiffany and Nicole when the suspect Genele Underwood, DOB 6/12/90, opened her car door and attempted to pull her out. Savannah stated that Tiffany, who was sitting in the passenger seat, was able to grab her and keep her from getting pulled out of the car. At this time, Nicole was sitting in the back seat exited the vehicle to attempt to get Genele away from the car. Nicole stated she had a baseball bat, in case she had to defend herself.

Savannah stated that when Genele was unable to get her out of the car, she sprayed the inside of her car with pepper spray, causing her and Tiffany to suffer from the side effects of pepper spray(skin irritation and burning eyes).

Nicole stated that Genele retaliated for OF24-3224, in which Genele's car was vandalized.

Savannah was transported to St. Lukes Hospital by New Bedford EMS, and Tiffany refused medical services.

Genele was gone before my arrival. I put out a Bolo to Unit 24(Ofc Parker) that Genele had left the scene wearing a red sweater heading west on Brock Ave. Unit 24(Ofc. Parker) was not able to locate Genele.

All parties involved were checked for warrants.
