My name is Harold Weeks and I am the father of Jennifer McCabe, a witness in the Karen Read Trial. I am writing to bring things to your attention regarding this case and the investigation into the State Police Trooper Michael Proctor.

Due to being a witness in this case, my daughter's life has been destroyed. The defense team, Karen Read and social media bloggers have made it their mission to attack her and her family. Attorney Alan Jackson has stated in open court, that he had already done enough damage to her, regarding her testimony. The blogger calls her a murderer, his followers stalk her, take pictures, yell in her face, drive by her house and scream profanities. She can't go out in public alone. One individual stated that she wanted to put a bullet in her head. Why??? All because she is a States witness in the Karen Read Trial. She has begged and pleaded for help. Her daughter, my granddaughter was admitted to a mental health program. Her children have been sexualized. Her family is attacked over social media daily.

I highlighted a quick snapshot to hopefully get your attention. After seeing what has happened to her over the past 16 months, I do not wish this on anyone. The Department of Justice intervened in a State Murder case, the reason why, I don't know, but I welcomed it. I figured that our Government had a reason to do what they did, in the end, they would clear the witnesses names. Well, that hasn't happened. Not only have their names not been cleared, but the investigation by the DOJ has only made things worse on her family. She is a State's witness to the charges that the State brought forward against Karen Read, but she is being treated as the villain. She is taunted daily that the FEDS are coming to get her. I feel that our Government has failed my family, friends, and our state and local law enforcement.

This imaginary conspiracy that the defense has created with the help of Social media bloggers, has taken a toll on everyone involved from the DA's office, The State Police investigation Team, The Canton Police, the Canton Fire Department, Medical professionals etc... The real investigation by the Federal Government should be focused on what Karen Read and her Defense team has done. They have created a mob mentality who are intimidating and bullying their way through the judicial system. It's time for you to Stand UP and do what is right. At this time, **your focus is on Trooper Michael Proctor, a good officer who had made a mistake on Private Text.** Please remember these were private messages. We have heard before from political leaders, that the Private life is just that PRIVATE. **Michael Proctor**, along with other law enforcement, DA Michael Morrissey, MSP Brian Tully, MSP Yuri Bukenic, MSP John Fanning, and Canton Chief Helana Rafferty have all **tried their best to help the Witnesses in this trail, and I have nothing but the utmost respect for them.**

She is only one of the witnesses, there are many more that have their own stories. She is a wife, mother, daughter, sister and friend. I ask you to imagine what is happening to my daughter and her family and put yourself in my shoes. She didn't ask for this, she is not a public official. She is the States Witness and **this case has destroyed her life.** Though her life has been upended, she is still standing because she is here for the real victim John O'Keefe and his family.

I ask that you put your focus where it should be, and that is to stand up and support the MA State Police, the Norfolk County DA and the State Witnesses. The State has worked diligently in charging the person responsible for the death of her friend John O'Keefe. **Your**

efforts to terminate Trooper Proctor will only undermine the great work that the State Police did with charging Karen Read and will continue to feed into the mob of Karen Read supporters who are harassing and pushing a false narrative to the public to circumvent the legal process.
